Overview of General Rules & Regulations:

• For the safety of visitors, absolutely no modern-day vehicles are allowed on Eckley Main Street between 10a.m. and 5 p.m. NO EXCEPTIONS. Side roads can be used to enter and exit. Parking is allowed in designated areas on the back streets only.

• All participants are invited to arrive at the museum on Fri. September 8th prior to 5 p.m. for set up and registration. All areas must be set up by 10 a.m. on Sat. September 9th.

• Re-enactors are asked to remain on site during the event and should not pack up their camps until 3 p.m. on Sun. September 10^{th} . Campfires must be at least 100 feet from any wooden structure, preferably mid-lot. No bonfires. Sod must be removed prior to making fires and replaced afterwards. There are designated watering and firewood locations.

• Anyone not re-enacting and not dressed in period attire must pay admission. • Weapons are only to be discharged in designated areas. All weapons are subject to inspection by unit leaders and PHMC weapons officers. • Please be courteous to all fellow re-enactors and respect the privacy of all current Eckley residents. Quiet hours begin at 9 p.m. Those who are disrespectful will be escorted from the premises.

• Specific information, rules and regulations will be distributed prior to the event's commencement on Sat. September 9th .

Rules and Regulations 2017

Civil War Encampment

Saturday, September 9th and Sunday, September 10th -10:00 am to 5:00 pm

Below is a list of rules and regulations you agree to abide by upon your group/personal registration for 1940s Weekend at Eckley Miners' Village Museum:

- For the safety of visitors, from 10 a.m.-5 p.m. Saturday and noon-5 p.m. Sunday, there will be absolutely no modern-day vehicles allowed on Eckley Main Street, no exceptions. Side roads are used to enter and exit the village, and parking is in designated areas only.
- All campsites will be set up by 10 a.m. on Sat. September 9th and/or by noon on Sun. September 10th. (All participants are encouraged to arrive Fri. September 8th at their convenience)
- Participants are asked to remain on site during event hours, and should not pack up their belongings prior to 5 p.m. on Sat. September 9th or 3 p.m. on Sun. September 10th.
- Campfires are to be made by digging up and removing sod, which will be replaced upon departure. Campfires should be at least 50 feet from any wooden structures, preferably mid-lot. Bonfires are prohibited. Water and firewood locations will be available.
- Any individuals not dressed in period costume will pay admission.
- Participation in programs is for educational purposes. There is no desire to create conflict with other groups, opposing military forces or guests. Vulgar language during event hours is not tolerated and will lead to dismissal from premises. Unacceptable behavior afterhours will also lead to dismissal from state grounds.
- No alcoholic beverages are permitted on state grounds.
- Certified Pennsylvania Historical and Museum Commission historic weapons safety officers subject all weaponry to inspection. There will be no firing of weaponry during this static event.
- Eckley is a museum as well as residential community. Following 9 p.m. quiet hours observance will show courtesy to both residents and fellow participants.
- The event is rain or shine, so please take the weather into account when packing for the weekend.
- Security will be patrolling the village, including afterhours.
- In the event you will not be attending the event but submit your registration form, please send a courtesy email to c-mpearce@pa.gov to notify us that you will not be in attendance.
