Overview of General Rules & Regulations:

- For the safety of visitors, absolutely no modern-day vehicles are allowed on Eckley Main Street between 10a.m. and 5 p.m. NO EXCEPTIONS. Side roads can be used to enter and exit. Parking is allowed in designated areas on the back streets only.
- All participants are invited to arrive at the museum on Fri. Aug. 2nd, prior to 9 p.m. for set up and registration. All areas must be set up by 10 a.m. on Sat. Aug. 3rd.
- Re-enactors are asked to remain on site during the event and should not pack up their camps until 4 p.m. on Sun. Aug. 4th. Campfires must be at least 100 feet from any wooden structure, preferably mid-lot. No bonfires. Sod must be removed prior to making fires and replaced afterwards. There are designated watering and firewood locations.
- Anyone not re-enacting and not dressed in period attire must pay admission. • Weapons are only to be discharged in designated areas. All weapons are subject to inspection by unit leaders and PHMC weapons officers. • Please be courteous to all fellow re-enactors and respect the privacy of all current Eckley residents. Quiet hours begin at 9 p.m. Those who are disrespectful will be escorted from the premises.
- Specific information, rules and regulations will be distributed prior to the event's commencement on Sat. Aug. 3rd.
